The **Philippine International Trading Corporation (PITC)** and the **Philippine Air Force (PAF)** intend to apply the sum of **PESOS: One Million Five Hundred Fifty Seven Thousand and 00/100 only (P1,557,000.00) (VAT Inclusive)** being the Approved Budget for the Contract (ABC) to payment under the contract for **Supply and Delivery of Thirty (30) Units Brand New Satellite Phone each with 250 Units Top-up Load (per unit) for the Philippine Air Force (PAF)**, more particularly describe as follows:

- Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- PITC and PAF now invite Bids from authorized Philippine Suppliers/Distributors with National Telecommunication Center (NTC) license for the Satellite Phone each with 250 Units Top-up Load (per unit) (hereafter referred to as GOODS).
- The bidding is open to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Delivery Period: Within Thirty (30) Calendar Days upon receipt of Notice to Proceed.
Delivery Place: 4211th SMS, 420th SW, Clark Air Base, Pampanga
- A prospective Bidder should have completed **within the last five (5) years** from the date of submission and receipt of bids at least a single contract similar to the contract to be bid amounting to at least **fifty percent (50%)** of the ABC of the project.
"Similar" contract shall mean **Communication Equipment**
- Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.



8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website at www.pitc.gov.ph**. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.

9. The complete set of bidding documents maybe acquired by interested bidders during office hours (8:00am – 4:00pm) but no later than 4:00 pm upon payment of a non-refundable fee as indicated above. The bidding documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the bid documents.
