A. REPLIES TO QUERIES OF BIDDERS:

Below are the queries/requests for consideration/clarification sent by the prospective bidder, which have been answered by the Philippine Air Force (PAF) and PITC Bids and Awards Committee I.

ZHUJAR MANUFACTURING, INC in its letter dated 07 August 2020, received by BAC on 07 August 2020.

Query 1:	We are manufacturer, importer and exporter of quality garments. We would like to bring into your notice that in the ITB clause 5.1 (f) of page 32 Bid Data Sheet of above-mentioned project stated that "Bidders must be Local Manufacturers" We would like to ask your good office if possible can we manufacture these items from our source outside the country. As in this pandemic situation manufacturing process is unstable due to lack of manpower (as some areas are being under hard lockdown workers are not able to come on work regularly) and strict quarantine guidelines by government.
PITC's Reply:	REQUEST DENIED It is the intention of the end-user (PAF) and the procuring entity (PITC) to require that the bidders are local manufacturers, the purpose is to provide much needed jobs to the local industry. Creating jobs and ensuring the safety of everyone specially in the current pandemic situation is a balancing act that the government is successfully addressing and we are expecting that the situation will be better at the time this project is awarded.

This **Supplemental Bid Bulletin No. 3** shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
