<p>We have downloaded the Bid Bulletin No.1 for the above project last Friday afternoon, March 01, 2019, which was posted on the PhilGEPS Website last February 28, 2019. And upon perusal thereof, based on our own understanding, we found some inconsistencies thereof and for that reason, we are respectfully requesting clarification on the above said document.</p> <p>On the required additional document to be submitted under the Financial Document, specifically the , Annex VIII-C which is a Unit Cost Analysis (UCA), the last part of the form conflicts the required information on the Bill of Quantities.</p> <p>With the above dissimilarities, our bid price on the BOQ and Detailed Estimate (UCA) will not match with each other computations were derived from different datas. This will also will probably be at variance to the figures on our Bid Form which might result into our disqualification.</p> <p>Moreover, not every line item of the BOQ has only one item that would qualify for one unit cost. Most of the line items has sub-items which will have different unit cost. Therefore, incorporation of unit cost for the line items with sub-items is not feasible.</p>	<p>Please refer to Unit Cost Analysis per Revised Annex VIII-C.</p>
