- The **Philippine International Trading Corporation (PITC)** and the **Philippine Army (PA)**, intend to apply the sum of Pesos: **Six Million Five Hundred Forty One Thousand Nine Thirty and 48/100 (₱6,541,930.48)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply of Labor and Materials for the Repair & Rehabilitation of Roadnets, Libingan ng mga Bayani (LNMB) for the Philippine Army (PA)**.

- Bids received in excess of the ABC shall be automatically rejected at bid opening.
- PITC** and **PA** now invite Contractors with valid and current Philippine Contractors Accreditation Board (PCAB) License with Classification / Category in General Engineering / General Building with Minimum Size Range of Small B and Minimum License Category of C or D, (hereinafter referred to as the "WORKS"). The PCAB license must indicate "PCAB registered contractor for Government Projects."
- The bidding is open to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
- Prospective Bidders should have completed a single contract similar to the Project amounting to at least fifty percent (50%) of the ABC adjusted to current prices using the National Statistics Office consumer price index.
However, contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. Provided, Bidder submits a duly notarized Affidavit that it has no similar experience on the Contract being bid per **Annex I-B**.
For purposes of this project, "similar contract" shall refer to contract involving **Asphalting of Roads**.
- Project Completion Period is within **One Hundred Twenty (120) calendar days** after receipt of the Notice of Site Possession.

7. Open competitive bidding will be conducted using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.” All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post Qualification procedures and Award of Contract shall be governed by R.A. 9184 and its Revised 2016 IRR.
8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website** at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00AM – 4:00PM) on weekdays only.
