2. PITC and RITM now invite bids from authorized Philippine dealers, distributors or resellers for the SUPPLY, DELIVERY, AND INSTALLATION OF VARIOUS BRAND NEW LABORATORY EQUIPMENT (BATCH 1) FOR THE RESEARCH INSTITUTE FOR TROPICAL MEDICINE (RITM) (hereafter referred to as GOODS).
3. A prospective Bidder must have completed a Single contract of similar nature within the last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.

Similar contract shall mean "**Laboratory/ Scientific Equipment**".

4. The **Delivery of GOODS** shall be within Sixty (60) calendar days upon receipt of Notice to Proceed (NTP).

5. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
6. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am-4:00pm) but not later than 4:00pm upon payment of a nonrefundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
