



INVITATION TO BID

SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ELEVEN (11) PACKAGES CONSISTING OF ONE HUNDRED TEN (110) UNITS BRAND NEW HEMODIALYSIS WITH VARIOUS ACCESSORIES AND CONSUMABLE MEDICAL DEVICES FOR THE DEPARTMENT OF HEALTH (DOH)

1. The **Philippine International Trading Corporation (PITC)** and the **Department of Health (DOH)** intend to apply the sum Pesos : **Two Hundred Fourteen Million Five Hundred Thousand & 00/100 only (₱214,500,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the Supply, Delivery, Installation and Commissioning of One Hundred Ten (110) Units Brand New Hemodialysis with Various Accessories and Consumable Medical Devices for the Department of Health (DOH).

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
3. **PITC** and **DOH** now invite bids from Manufacturers or Local First Tier Distributors of the principal manufacturer for the Supply, Delivery, Installation and Commissioning of One Hundred Ten (110) Units Brand New Hemodialysis with Various Accessories and Consumable Medical Devices (hereinafter referred to as GOODS).

"First Tier Distributor" shall mean a Philippine company directly appointed by the principal manufacturer of the **Hemodialysis Equipment** with ongoing business relationship over the last five (5) years, regardless of the type of equipment/products carried for the principal manufacturer.

Foreign Manufacturers must be represented by a Philippine based company.

4. A prospective Bidder should have completed a contract of similar nature within the **last five (5) years** from the date of submission and receipt of bids amounting to at least **fifty percent (50%)** of the ABC.

"Similar contract" shall mean **"Medical Equipment"**.

5. The Brand of the Hemodialysis Equipment being offered must have been in the Philippine Market for at least **twenty (20) years**.
6. **Project Completion Period:** Bidder must deliver, install, test and commission within **One Hundred Twenty (120)** calendar days upon receipt of Notice of Site Readiness and Possession.
7. **Delivery / Installation Sites:** On-site delivery and installation to the recipient hospitals included in the DOH Allocation / Distribution List (Reference: **Annex V-A2** of the Bidding Documents)
8. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

9. The complete set of Bidding Documents may be acquired by interested bidders from Monday to Friday between 9:00AM to 2:00PM upon payment of a non-refundable fee as indicated above and look for the following BAC Secretariat:

It may be also downloaded free of charge from the website of the PhilGEPS and the PITC website. However, only those who have paid the cost of Bidding Documents at least one (1) day before the submission of their bids will be allowed to bid.

The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

Bidders may pay for the cost of Bidding Documents thru any of the following modes of payment:
