1. The **Philippine International Trading Corporation (PITC)** and the **Philippine Air Force (PAF)** intend to apply the sum of **PESOS: Sixteen Million Four Hundred Seventy-One Thousand One Hundred Forty-Two and 70/100 (₱16,471,142.70) (Inclusive of VAT)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply and Delivery of 1,135 Pieces Brand New Flight Suit, Freedom Green for the Philippine Air Force (PAF)** more particularly described as follows:

2. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
3. **PITC and PAF** now invite Bids from duly authorized local manufacturers, distributors, dealers or suppliers for the **Supply and Delivery of 1,135 Pieces Brand New Flight Suit, Freedom Green** (hereafter referred to as GOODS).
4. The bidding is open to Filipino citizen/sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Required Delivery Period and Delivery Place shall be as follows:

6. A prospective Bidder should have completed **within the last five (5) years** from the date of submission and receipt of bids, **a single contract** of similar nature amounting to at least **twenty-five percent (25%)** of the ABC of the item being bid for.

“Similar” contract shall mean Personal Survival Equipment.

7. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.



8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website** at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
9. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but no later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.
- Bidding Documents may be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- However, bidders who previously bought Bidding Documents under Bid Ref. No. MPG-BI-2019-189 may acquire Bidding Documents free of charge upon presentation of the Official Receipt for the previous project.
- For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the Bidding Documents.
