**WHEREAS**, on 04 September 2017, PITC caused the posting of the Invitation to Bid of the public bidding for the procurement project entitled **Supply and Delivery of 14,766 pieces Brand New Lousy Hat, Camouflage 100% Cotton for the Philippine Army (PA) under Bid Ref. No. MPG-B1-2017-201** in the PhilGEPS, PITC Website, and in conspicuous place within the premises of its office continuously for seven (7) calendar days, as follows:

**WHEREAS**, in response to the above-mentioned postings, three (3) prospective bidders purchased Bidding Documents for the subject item, namely:

1. Goldbell Philippines Impex Corp. (hereinafter "**Goldbell**");
2. Neala Enterprises (hereafter "**Neala**"); and
3. Jeje Enterprises (hereinafter "**Jeje**");

**WHEREAS**, during the scheduled submission and opening of bids on **25 September 2017**, only **Jeje** and **Neala** submitted their Eligibility and Technical Documents and their Financial Bids for the subject item;

**WHEREAS**, on said bid opening date, this Committee proceeded to open the Eligibility and Technical documents of **Jeje** and declared **Jeje's** eligibility and technical submittals as "**Passed**";

**WHEREAS**, on said bid opening date, this Committee proceeded to open the Eligibility and Technical documents of **Neala** and declared **Neala's** eligibility and technical submittals as "**Passed**";

**WHEREAS**, having passed the eligibility and technical checking, this Committee proceeded to open the financial bids of **Jeje** and **Neala**, the result of which are as follows:

WHEREAS, on 02 October 2017, after conducting a bid evaluation, this Committee issued to Neala the Notice of Lowest Calculated Bid for the subject item;

WHEREAS, pursuant to the Post-Qualification procedures under the 2016 Revised IRR of RA 9184 and after careful examination, validation and verification of the eligibility, technical and financial requirements on post-qualification, the bid submitted by Neala Enterprises was found to be post-disqualified as shown by the corresponding Notices of Post-Disqualification, a copy of which is hereto attached as Annex "B" and made integral part hereof;

WHEREAS, no Motion for Reconsideration was filed by Neala Enterprises within the period prescribed therefor;

WHEREAS, being the Bidder with the 2<sup>nd</sup> lowest bid, this Committee conducted a Bid Evaluation and on 12 January 2018 issued to Jeje the Notice of 2<sup>nd</sup> Lowest Calculated Bid;

WHEREAS, pursuant to the Post-Qualification procedures under the 2016 Revised IRR of RA 9184 and after careful examination, validation and verification of the eligibility, technical and financial requirements on post-qualification, the bid submitted by JEJE ENTERPRISES was found to be the LOWEST CALCULATED AND RESPONSIVE BID, as shown by the corresponding Notice of Post Qualification, a copy of which is hereto attached as Annex "C" and made an integral part hereof;


NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee I, hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare JEJE ENTERPRISES as the bidder with the Lowest Calculated and Responsive Bid for the subject item;
- b) To recommend award of the Contract to JEJE ENTERPRISES for the procurement project entitled *Supply and Delivery of 14,766 pieces Brand New Lousy Hat, Camouflage 100% Cotton for the Philippine Army (PA) under Bid Ref. No. MPG-B1-2017-201*; and
- c) To recommend the foregoing findings for approval of the PITC President.
