SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF ONE (1) LOT BRAND NEW AIR-CONDITIONING UNITS FOR THE NATIONAL BUREAU OF INVESTIGATION (NBI)

1. The **Philippine International Trading Corporation (PITC)** and the **National Bureau of Investigation (NBI)** intend to apply the sum of **Pesos: Four Million Four Hundred One Thousand Eight Hundred Fifty Five Only (P 4,401,855.00)** inclusive of VAT, being the Approved Budget for the Contract (ABC) to payment under the contract for the Supply, Delivery, Installation, Testing and Commissioning of One (1) Lot Brand New Air-Conditioning Units for the National Bureau of Investigation (NBI) more particularly described as follows:

2. Financial Proposal received in excess of the ABC shall be automatically rejected. The Bids and Awards Committee have the option to negotiate on the Financial Proposal received that is within the ABC.
3. **PITC** and **NBI** now invite bids from Manufacturers or Authorized Philippine Suppliers, Dealers or Resellers for the Supply, Delivery, Installation, Testing and Commissioning of One (1) Lot Brand New Air-Conditioning Units (hereafter referred to as GOODS).
4. **Project Completion Period:** Within Ninety (90) calendar days after receipt of Notice to Proceed.
Project Delivery Site: NBI Clearance Building, United Nations Avenue, Ermita, Manila.



5. The bidding is open to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
6. A prospective Bidder must have completed a Single contract of similar nature within the last five (5) years from the date of submission and receipt of bids amounting to at least fifty percent (50%) of the ABC of the item being bid.

“Similar” contract shall mean **Supply and Delivery of Air-conditioning Units.**

7. Negotiation will be conducted using a non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this negotiation including Eligibility Checking, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.
