The **Philippine International Trading Corporation (PITC) and Philippine Army (PA)**, through **ASA Nr 5100-2019-0321 dated 04 November 2019** intend to apply the sum of **Pesos: Three Million Three Hundred Thirty-Five Thousand Seven Hundred Twenty-Four and 48/100 (₱3,335,724.48)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply of Labor and Materials for the Repair & Improvement of Ammunition Battalion (AABn) Warehouse for the Philippine Army (PA) per PITC Bid Reference No. MPG-B2-2020-336**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine International Trading Corporation and the Philippine Army (PA)** now invite bids for the above Procurement Project. Completion of the Works is required **within one hundred (100) calendar days from receipt of Notice of Site Possession**. Bidders should have completed a contract similar to the Project.
